DECREE

ON THE PENALTIES AND OTHER MEASURES APPLICATION TOWARDS THE VIOLATOR OF LAWS AND REGULATIONS ABOUT THE ENTRY AND EXIT AND FOREIGNER MANAGEMENT IN LAO PDR

- Pursuant to the Law on the Government of the Lao PDR, Ref No: 04/NA, dated 08 November 2016;
- Pursuant to the Law on the Entry and Exit and Foreigner Management in Lao PDR, Ref No. 59/NA, dated 26 December 2014;
- Pursuant to the propose of the Ministry of Public Security, Ref No: 3488/PS, dated 29 December 2020.

The Government of the Lao PDR issues the Decree:

Section 1

General Provisions

Article 1 Purposes

This decree outlines the principles of rate fines and other measures for the violation of laws and regulations about the entry and exit and foreigner management in Lao PDR as references for implementing the accurate fines and other measures against the infringer, in accordance with the regulation and the law on the entry-exit and foreigners management in Lao PDR, to ensure the public and social order to contribute the protection and the development of the Nation.

Article 2 The penalties and other measures

The penalties are financial measures that apply to the administrative violator on the entry - exit and foreigner management in Lao PDR.

The application of other measures is an additional measure from the penalties shall include the education, warning, preliminary inquiry, twenty-four hours detention and confiscate any of document, materials, equipment and vehicles in which related to the infringement as well as the cancellation of registration and business license, suspension or revocation of business license or submit to the relevant departments to withdraw business license.

For foreigner and stateless persons, beyond the penalty fine and other measures, shall be deported.

Article 3 Terminologies

The terms used in this decree shall have the following meanings:

1. **Invalid passport use** hereinafter refers to as the use of other persons', forgery, altered passport and inadequate or incomplete information to enter and leave Lao PDR;
2. **Avoidance of inspection or unstamped the entry and exit from the immigration and emigration police officer at the border checkpoints** refers to the entry and exit of individual at the border crossings and international airports by designated authority in intention or negligence action to avoid the inspection or unstamped the entry and exit from the authority as stipulated in the laws and regulations;
3. **Untargeted work performance as prescribed by the authority** refers to working performance that does not comply with the targets and objectives set on which the authority and related departments allow;
4. **Unauthorized entry to work** refers to the smuggling to work without Labor visa, work permit and stay permit card;
5. **Illegitimate business license lease** refers to the lease of business license of another person or legal entity to conduct business without the authorities' and others relevant department's permission;
6. **Unlawful business license rental** refers to the rent of another person or juristic person to lease his or her business license to conduct business without the authorities' and others relevant department's permission;
7. **Entering for a profession to earn money without permission** refers to carry out occupations such as retail, restaurant, dressmaking, street vending, traveling to buy used with bicycle or motorcycle, mobile massage, beauty salon, nail cutter, scale weight service for health, building construction, automobiles repair, furniture and others to earn money on which against the laws, regulations and occupations reserved by the government for the Lao citizen periodically;
8. **Unregulated importation and improper use of foreign worker in line with the targets set** refers to the importation of foreign worker in accordance with the laws and regulations without the best control of worker, accommodation and the use of labor including the use of non-targeted labor;
9. **Non-notification of foreigner accommodation and stateless person** refers to individual, legal entity and organization owns office, organization, hotel, guesthouse, factory, manufactory and other lodgments without notifying the said foreigner and stateless person to the local and relevant authorities;
10. **Spousal cohabitation** refers to the cohabitation of individual without the legal registration of marriage;

11. **Intentional illicit stay in Lao PDR** refers to staying in Lao PDR exceeds ninety days whereas the stay permit is yet not renewed by the relevant authorities;
12. **Visa on arrival** refers to the citizen of countries, in accordance with the notice of the Ministry of Foreign Affairs, listed in watch list could not apply for VoA .

Article 4 Principles on the Penalties and other Measures

Penalties and other measures against the violator(s) on the entry and exit and foreigner management in Lao PDR, in accordance with the following principles, shall be:

1. In Comply with the laws and regulations, conventions and international agreements on which the Lao PDR is a party;
2. Centralized and unified management across the country;
3. Ensuring the transparency, fairness and auditability.

Article 5 Scope of Application

This decree applies to individual, legal entity and organization violated the laws and regulations on the entry and exit and foreigner management in Lao PDR.

Section 2

Penalties and other measures to the violator of entry and exit Lao PDR

Article 6 Violation of Entry and Exit the Lao PDR

Behaviors that cause the violation of entry and exit Lao PDR are as follows:

1. Entry and exit Lao PDR without a passport;
2. Entry and exit Lao PDR by using an invalid passport;
3. Entry and exit Lao PDR without going through the official border checkpoints and international airports;
4. Use of passport and temporary border pass in illegitimate succinct;
5. Overstay beyond his/her timeframe illegitimately;
6. Avoidance of inspection or unstamped the entry and exit from the immigration and emigration police officer at the border checkpoints and international airports;
7. Facilitating or assisting the ones who illegally entry and exit Lao PDR.

Article 7 Entry and exit Lao PDR without passport

Lao citizen, alien, foreigner and stateless person entering and leaving the Lao PDR without a passport shall be fined and applied the other following measures:

1. The first time shall be fined two million kip per person with a memorandum note;
2. The second time shall be fined three million kip per person with a memorandum note;

3. The third time shall be fined five million kip per person with a memorandum note and other measures shall be applied on a case-by-case basis.

For foreigner and stateless person is not only pay for a charge but also deported to his/her country of origin.

Article 8 Entry and exit Lao PDR by using invalid passport

Lao citizen, alien, foreigner and stateless person entering into and leaving the Lao PDR by using invalid passport shall be fined from seven million Kip to twelve million Kip per person per time with a memorandum note and other measures shall be taken into account on a case-by-case basis.

For the alien, foreigner and stateless person, is not only pay for a charge but also deported to his/her country of origin.

Article 9 The entry and exit at unauthorized International Checkpoints and International Airports.

Lao citizen, alien, foreigner and stateless person enters into or leaves the Lao PDR at authorized International Checkpoints and International Airport shall be committed of fine and applied for other following measures:

1. The first time shall be fined two million Kip per person with a memorandum note;
2. The second time shall be fined three million Kip per person with a memorandum note;
3. The third time shall be fined four million Kip per person with a memorandum note and applied for other measures on a case-by-case basis.

For alien, foreigner and stateless person. is not only pay for a charge but also deported to his/her country of origin and prohibited to enter into Lao PDR.

Article 10 The use of passport and temporary border pass beyond an illegitimate succinct.

Foreigner with his/her passport or temporary border pass beyond an illegitimate succinct shall be fined and applied for other following measures:

1. The first time shall be fined one million Kip per person with a memorandum note;
2. The second time shall be fined two million Kip per person with a memorandum note;
3. The third time shall be fined three million Kip per person with a memorandum note and expelled and prohibited to enter into Lao PDR.

Article 11. Overstay

Foreigner and stateless person stay exceeding the duration of time of which indicated in each category: Transit Visa (TR-B3), Tourist Visa (T-B3), Non-Immigrant Visa (NI-B3),

Immigrant Visa (I-B3). Except, the task of immigration field shall be fined and other following measures:

1. Those who use the passport shall be fined one hundred thousand Kip per day with memorandum note;
2. Those who use border pass and temporary border pass be fined fifty thousand kip per day with a memorandum note.

Article 12 Avoidance of inspection or unstamped the entry and exit on passport from the immigration and emigration police officer at the border checkpoints and international airports

Lao citizen, alien, foreigner and stateless person enters into and leaves the Lao PDR through the official border checkpoints and international airports .Yet, intentionally neglect to inspect and unstamped on passport from the immigration and emigration police officer at the border checkpoints and international airports shall be fined two million kip per with a memorandum note and get educated.

For alien, foreigner and stateless person is not only pay for a charge but also deported to his/her country of origin-and prohibited to enter into Lao PDR

Article 13 Facilitating or Smuggling in Persons into Lao PDR

The facilitating or **smuggling in Persons into** and leave the Lao PDR shall be, abide by the Law and Regulations, paid for penalty and take into account the other following measures:

1. In the event of legal entity carries passengers of the nation on board which could not apply for visa on arrival and also yet visa approved shall be, The notice of the Ministry of Foreign Affair, paid three million kip per person with a memorandum note;
2. In the event of legal entity carries passenger whose validity of passport is less than one hundred and eighty days without authorized from the immigration officer shall be paid three million kip per person with a memorandum note;
3. In the event of legal entity carries on board without passenger list in manifest shall be ten million kip with a memorandum note;
4. In the event of individual and legal entity to facilitate or assist the imposter shall be paid fifteen million kip with a memorandum note;
5. In the event of individual and legal entity intends to facilitate another person to enter and exit Lao PDR by taking vehicles or either Which contrast with Law and regulation shall be paid fifteen million kip with a memorandum note.

In the event of individual and legal entity against point 1 to 5 of this article more than two times shall be double fined of the violation with a memorandum note and other measures shall be applied on a case-by-case basis.

Section 3

Penalties rate and other measures against violator on foreigner management in Lao PDR

Article 14 Violations of the Foreigner Management in Lao PDR

Behaviors that violate the laws and regulations on the foreigner management in Lao PDR are as follows:

1. Overstay on his time frame permitted;
2. Work performance does not meet the goals set by the authority;
3. Run business without permission;
4. Working without permission;
5. Leasing an illegal business license;
6. Renting an illegal business license ;
7. Seek for a profession to raise income without permission;
8. Illegal admission for foreigner, stateless person to work;
9. Relevant authority is not informed the accommodation of foreigner and stateless person;
10. The importation of foreign worker without best control and the use of labor is not in line with the targets set by the authority;
11. Forming a family or living together as a couple or getting married without legal family registration;
12. Willingly sneak and hide in Lao PDR;
13. Facilitating, providing accommodation or hiding foreigner, stateless person who violated the laws and regulations of foreigner management in Lao PDR.

Article 15 Overstay on his time frame permitted

Foreigner and stateless person overstay on his/her timeframe permitted as categorized of Diplomatic visa(D-A1), Service visa (S-A2), Spouse visa (SP-B3), Courtesy visa (C-B1), Expert visa (E-B2), Business visa (NI-B2/ I-B2), Student visa (ST-B2), Mass Media visa(M-B2) and Labor visa shall be fined one hundred thousand Kip per day with a warning record and other measures shall be applied on a case-by-case basis.

Article 16 An officially untargeted working

Foreigner and stateless person whose work is not in line with the targets set by the authority shall be fined and applied for other measures as follows:

1. The first time shall be fined two million Kip per person with a memorandum note;
2. The second time shall be fined three million Kip per person with a memorandum note;

3. The third time shall be fined five million Kip per person with a memorandum note, the overriding of registration, stay permit and shall be expelled as well as prohibited to enter into Lao PDR.

Article 17 Run business without permission

Foreigner and stateless person enter into Lao PDR for a business without registering an enterprise or without a business license shall be fined and applied other measures as follows:

1. The first time be fined four million Kip with a memorandum note;
2. The second time be fined seven million Kip with a memorandum note and suspending business operations;
3. The third time shall be fined ten million Kip with a memorandum note and overriding of the business operation and shall be deported and prohibited to enter into Lao PDR.

Article 18 working without permission

Foreigner and stateless person who come to work in Lao PDR without permission shall be fined and applied other measures as follows:

1. The first time shall be fined one million Kip per person with a memorandum note;
2. The second time shall be fined two million Kip per person with a memorandum note;
4. The third time shall be fined three million Kip per person with a memorandum note and shall be deported as well as prohibited to enter into Lao PDR.

Article 19 Illegal leasing of business license

Foreigner and stateless person, in case of leasing business license of individual, legal entity and organization illegally, shall be fined and applied other measures as follows:

1. The first time shall be fined five million Kip with a memorandum note;
2. The second time shall be fined ten million Kip with a memorandum note and deported as well as prohibited to enter into Lao PDR.

Article 20 Illegal renting of business license

Individual, legal entity and organization that illegally renting out business license to foreigner and stateless person will be fined and applied other measures as follows:

1. The first time shall be fined four million Kip with a memorandum note;
2. The second time shall be fined seven million Kip with a memorandum note;
3. The third time shall be fined ten million Kip with a memorandum note and proposed to the relevant departments to revoke the enterprise registration and business license.


Article 21 seek for a profession to raise income without permission

Foreigner and stateless person who enter into Lao PDR for an occupation to raise income shall be, in contrast with the laws and regulations or a reserved career that the government provides for Lao Citizen, fined and applied for other measures as follows:

1. The first time shall be fined one million Kip with a memorandum note;
2. The second time be fined two million Kip per person with a memorandum note;
3. The third time shall be fined five million Kip per person with a memorandum note, other measures shall be applied on a case-by-case basis as well as deported and prohibited to enter into Lao PDR.

Article 22 Illegal admission for foreigner, stateless person to work

Individual, legal entity and organization that bring foreigner and stateless person to work without Labor visa, work permit and stay permit card shall be fined and applied other measures as follows:

- 
1. The first time shall be fined two million Kip per person with a memorandum note;
 2. The second time shall be fined four million Kip per person with a memorandum note;
 3. The third time shall be fined six million kip per person with a memorandum note and proposed to the relevant departments to revoke the business license and deported as well as prohibited to enter into Lao PDR.

Article 23 Relevant authority is not informed on the accommodation of foreigner and stateless person

Individual, legal entity and organization is an owner houses and residences do not notify the accommodation of foreigner and stateless person shall be fined five hundred thousand Kip per person with a memorandum note and also get educated.

Article 24 The importation of foreign worker without best control and the use of labor is not in line with the targets set by the authority

Individual, legal entity and organization that have already imported foreign workers YET, in appropriate control and it is not accorded the targets set by the authority shall be fined and applied other measures as follows:

1. The first time shall be fined three million Kip per person with a memorandum note;
2. The second time shall be fined six million Kip per person with a memorandum note;
3. The third time shall be fined nine million Kip per person with a memorandum note and proposed to the relevant departments to revoke the enterprise registration and business license.

Article 25 Forming a family or living together as a couple or getting married without proper family registration

Foreigner and stateless person forming a family or live together as a couple or marry a Lao citizen without proper marriage registering in accordance with the laws and regulations shall be fined and applied other measures as follows:

1. The first time shall be fined four million Kip per couple with a memorandum note;
2. The second time shall be fined six million Kip per couple with a memorandum note;
3. The third time shall be fined eight million Kip per couple with a memorandum note and other measures shall be applied on a case-by-case basis.

For foreigner and stateless person upon paid for penalty and applied to other measures, the business registration and stay permit card shall also be revoked then, expelled from Lao PDR.

Article 26 Willingly sneak and hide in Lao PDR

Foreigner and stateless person intentionally hiding in Lao PDR shall be fined twenty million Kip per person and deported and prohibited to enter into Lao PDR.

Article 27 Facilitating, providing accommodation or hiding foreigner, stateless person who violate the laws and regulations about the foreigner management in Lao PDR

Individual, entity and organization that facilitate, provide accommodation or hiding foreigner, stateless person who violate the laws and regulations on the foreigner management in Lao PDR shall be fined from two million Kip to five million Kip per person, per one time with a memorandum note and also get educated.

For foreigner and stateless person Upon paid for the penalty and applied for other measures, the business registration and stay permit card shall also be revoked then, expelled from Lao PDR.

Section 4

Implementation of penalties and application of other measures

Article 28 Implementation of penalties and application of other measures

The Department of Public Security implements the penalties and application of other measures for violation of the laws and regulations on the entry and exit and foreigner management in Lao PDR and widespread disseminate to public attend in the implementation of this decree.

1. At the ministerial level are the Immigration Department and the Department of Foreigner Management under the General Department of Public Security;
2. At the provincial level are the Immigration Division and the Division of Foreigner Management under the Public Security Office or the assigned police officer;

3. At the district level are the Immigration Unit and Foreigner Management Police Unit under the Division of Public Security or the assigned police officer.
4. All categories of checkpoints.

Article 29 Rights and Duties of the Immigration Department

The Immigration Department has the following rights and Duties:

1. Public propaganda, disseminate of laws and regulations on the penalties and the application of other measures of violating the laws and regulations on the entry and exit Lao PDR;
2. Determine the format of the penalty form and the application of other measures breaches the laws and regulations in engage with the entry and exit Lao PDR;
3. The violation of laws and regulations shall be fined on the entry and exit Lao PDR as stipulated in Articles 7,8,9,10,11,12 and 13 of this decree;
4. Monitor and inspect the immigration officers across the country for implementation of penalty and the application other measures ;
5. Conduct to deport the violator of laws and regulations on the entry and exit Lao PDR ;
6. control and list up those who has been banned to enter into Lao PDR on immigration and foreigner management in Lao PDR;
7. Detention, conduct to inquiry for gathering the preliminary evidence within twenty-four hours;
8. Coordinate with relevant departments in the implementation of penalties and the application of other measures as an integrated implementation;
9. Summarize, conclude and report the implementation of the penalties and application of other measures on the entry and exit Lao PDR to the higher levels regularly;
10. Exercise the rights and perform other duties as stipulated in the laws and regulations.

Article 30 Rights and Duties of the Foreigner Management Department


The Foreigner Management Department has the following rights and Duties:

1. Public propaganda, disseminate of laws and regulations on the penalties and application of other measures to the violator of laws and regulations on the foreigner management in Lao PDR;
2. determine the format of the penalty form and the application of other measures breaches the laws and regulations on the foreigner management in Lao PDR;
3. The violation of laws and regulations shall be fined in engage with the foreigner management in Lao PDR as stipulated in articles 15,16,17,18,19,20,21,22,23,24,25,26 and 27of this decree;
4. Monitor and inspect the foreigner management officers across the country for implementation of penalty and the application other measures;

5. Conduct to deport the violator of laws and regulations on the foreigner management in Lao PDR;
6. control and list up those who has been banned to enter into Lao PDR on foreigner management in Lao PDR;
7. Detention, conduct to inquiry for gathering the preliminary evidence within twenty-four hours;
8. Coordinate with relevant departments in the implementation of penalties and the application of other measures as integrated implementation;
9. Summarize, conclude and report the implementation of the penalties and the application of other measures on the foreigner management in Lao PDR to higher levels regularly;
10. Exercise rights and perform other duties as stipulated in the relevant laws and regulations.

Article 31 Rights and Duties of the Immigration Division at the provincial level

The Immigration Division has the following rights and Duties:

- 
1. Public propaganda, disseminate of laws and regulations on the penalties and application of other measures of violating the laws and regulations on the entry and exit Lao PDR;
 2. The violation of laws and regulations shall be fined in engage with the entry and exit Lao PDR as stipulated in articles 7,8,9,10,11,12 and 13 of this decree;
 3. Monitor and inspect the immigration officers across the country for implementation of penalty and the application other measures;
 4. Conduct to deport the violator of laws and regulations on the entry and exit Lao PDR as agreed by the Provincial headquarters of Public Security and then report to the Ministry of public security;
 5. Summarize and report the list of individuals who is banned to enter into Lao PDR to the Immigration Department;
 6. Detention, conduct to inquiry for gathering the preliminary evidence within twenty-four hours and report to the Immigration Department;
 7. Coordinate with relevant departments in the implementation of penalties and the application of other measures as integrated implementation;
 8. Summarize, conclude and report the implementation of the penalties and application of other measures on the entry and exit Lao PDR to the higher levels regularly;
 9. Exercise the rights and perform other duties as stipulated in the laws and regulations.

Article 32 Rights and Duties of the Foreigner Management Division, Public Security at the provincial level

The Foreigner Management Division has the following rights and Duties:

1. Public propaganda, disseminate of laws and regulations on the penalties and application of other measures of violating the laws and regulations on the foreigner management in Lao PDR;

2. The violation of laws and regulations shall be fined on the foreigner management in Lao PDR as stipulated in articles 15,16,17,18,19,20,21,22,23,24,25,26 and 27 of this decree;
3. Monitor and inspect the foreigner management officers across the country for implementation of penalty and the application of other measures ;
4. Conduct to deport the violator of laws and regulations on the foreigner management in Lao PDR as agreed by the Provincial headquarters Public Security and report to the Ministry of public security;
5. Summarize and report the list of prohibited entrants into Lao PDR to its own authorize;
6. Detention, conduct to inquiry for gathering the preliminary evidence within twenty-four hours;
7. Coordinate with relevant departments in implementation of penalties and the application of other measures as integrated implementation;
8. Summarize, conclude and report the implementation of the penalties and application of other measures on the foreigner management in Lao PDR to the higher levels regularly;
9. Exercise the rights and perform other duties as stipulated in the laws and regulations.

Article 33 Rights and Duties of the Immigration Unit at the district level

The Immigration Unit has the following rights and Duties:

1. Public propaganda, disseminate of laws and regulations on the penalties and application of other measures to the violator of laws and regulations on the entry and exit Lao PDR within the scope of its responsibilities;
2. The violation of laws and regulations shall be fined on the entry and exit Lao PDR as stipulated in Articles 8,9,10,11,12 and 13 of this decree;
3. Detention, conduct to inquiry for gathering the preliminary evidence within twenty-four hours as well as report and submit to the Provincial headquarters of Public Security for further actions;
4. Coordinate with relevant departments in implementation of penalties and the application of other measures as integrated implementation;
5. Summarize, conclude and report the implementation of the penalties and application of other measures on the entry and exit Lao PDR to the higher levels regularly;
6. Exercise the rights and perform other duties as stipulated in the laws and regulations.

Article 34 Rights and Duties of the Foreigner Management Unit, Public Security at the district Level


The Foreigner Management Unit has the following rights and Duties:

1. Public propaganda, disseminate of laws and regulations on the penalties and application of violating the laws and regulations on the foreigner management in Lao PDR within the scope of its responsibilities;

2. The violation of laws and regulations shall be fined on the foreigner management in Lao PDR as stipulated in Articles 15,16,17,18,19,20,21,22,23,24,25,26 and 27 of this decree;
3. Detention, conduct to inquiry for gathering the preliminary evidence within twenty-four hours as well as report and submit to the Provincial headquarters of Public Security for further actions;
4. Coordinate with relevant departments in implementation of penalties and the application of other measures as integrated implementation;
5. Summarize, conclude and report the implementation of the penalties and application of other measures on the foreigner management in Lao PDR to the higher levels regularly;
6. Exercise the rights and perform other duties as stipulated in the laws and regulations.

Article 35 Rights and Duties of Immigration Checkpoints

The Immigration Checkpoints has the following rights and Duties:

- 
1. Public propaganda, disseminate of laws and regulations on the penalties and application of other measures to the violator of laws and regulations on the entry and exit Lao PDR within the scope of its responsibilities;
 2. The violation of laws and regulations shall be fined on the entry and exit Lao PDR as stipulated in articles 8,9,10,11,12 and No. 2, 3, 4 in article 13 of this decree;
 3. Conduct to expel the violator of laws and regulations on the foreigner management in Lao PDR as agreed by the higher ranking;
 4. Collect facts and control the list of prohibited entrants in Lao PDR on which violate the laws and regulations on the entry and exit and foreigner management;
 5. Detention, conduct to inquiry for gathering data and preliminary evidence within twenty-four hours as well as report and submit to the higher ranking respectively for further actions;
 6. Coordinate with relevant departments in the implementation of penalties and the application of other measures as integrated implementation;
 7. Summarize, conclude and report the implementation of the penalties and application of other measures on the entry and exit Lao PDR to the higher levels regularly;
 8. Exercise the rights and perform other duties as stipulated in the laws and regulations.

Article 36 Responsibilities of the Sectors and Local Authorities

The Sector of Labor and Social Welfare, Industry and Commerce, other sectors and local authorities are responsible for cooperating, monitoring, providing information and coordinating with the security sector on the violation of laws and regulations about the entry and exit and foreigner management in Lao PDR. For the application of measures against the violator is the responsibility of the Ministry of Public Security as defined in this decree.

Section 5

The Money Management and Expenditure Collected from the Penalties

Article 37 The Money management and expenditure collected from the penalties

All fines collected from the violations of this decree shall be transferred to the state budget. The budget used for the entry and exit and foreigner management in Lao PDR is the state budget and other sources as stipulated in the laws and regulations.

Article 38 Budget Expenditure Targets

Budget expenditure targets in the work of entry and exit and foreigner management in Lao PDR are as follows:

1. Organize to train, public propaganda, disseminate the laws, this decree and other regulations in engage with the violation of the entry and exit and foreigner management in Lao PDR;
2. Monitor and inspect the implementation of laws, this decree and other regulations on the violation of the entry and exit and foreigner management in Lao PDR;
3. Upgrading the knowledge and skills of officers those who work in the field of the entry and exit and foreigner management in Lao PDR;
4. Using it in the management and deportation the foreigner and stateless person who violate the laws and regulations of the entry and exit and foreigner management in Lao PDR;
5. Procurement of materials and facilities for the entry and exit and foreigner management in Lao PDR;
6. Other works performance on the entry and exit and foreigner management in Lao PDR;

Section 6

Final provisions

Article 39 Implementation

Assign the Ministry of Public Security to implement this decree in coordination with the line ministries, government agencies which equivalent to the ministries and local authorities.

Ministries, government agencies which equivalent to ministries, local authorities and relevant departments recognize and strictly implement this decree.

Article 40 Effectiveness

This decree comes into force fifteen days after the signing and submission to the official gazette.

Any provisions that are inconsistent with this Decree shall be repealed.

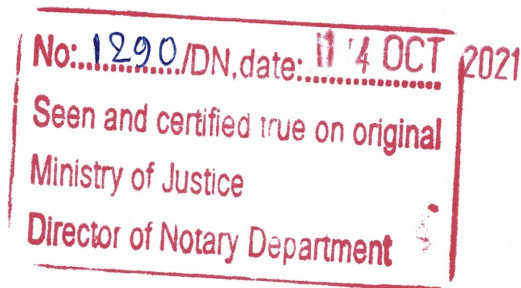
